DIRECTIONS FOR USE

It is a violation of Federal law to use Far-Go® herbicide in any manner inconsistent with its labeling.

This label must be in possession of the user at the time of application.

RECOMMENDATIONS

When used according to label directions, this product may be applied in the fall or spring to control wild oats in sugarbeets.

This product must be incorporated into the soil to a minimum depth of 2 inches. Follow all label directions for soil incorporation of this product.

APPLICATION RATES AND TIMING

Application is limited to one per growing season, either spring or fall, and must not exceed 1.5 quarts per acre.

Use Rate

1.5 quarts/acre

When to Apply

Fall application—Within three weeks of normal freeze-up or until snow cover occurs.

1.5 quarts/acre

Spring application—Before seeding

and before wild oats germinate.

PERSONAL PROTECTIVE EQUIPMENT

Mixers, loaders, applicators*, flaggers*, and other handlers must wear:

- Long-sleeved shirt and long pants
- Shoes plus socks

In addition, mixers, loaders, equipment cleaners and handlers exposed to the concentrate must wear chemical-resistant gloves.

ENGINEERING CONTROLS

- Aerial applicators must be in an enclosed cockpit.
- Flaggers must be in an enclosed cab.
